SALE AND SUPPLY OF ALCOHOL ACT 2012

OFF-LICENCE

Sections 17, and 64, Sale and Supply of Alcohol Act 2012

PURSUANT to the Sale and Supply of Alcohol Act 2012(the Act), Alchemyst Brewing Limited (the licensee) is authorised to sell or deliver alcohol on or from the premises situated at 1/20 BROOK STREET, PARKVALE, TAURANGA 3112, , and known as "ALCHEMY BREWING", to any person for consumption off the premises and to supply complimentary samples of alcohol on the premises.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

CONDITIONS

This licence is subject to the following conditions:

Alcohol may be sold on, or delivered from, the premises for consumption off the premises, or supplied free as a sample for consumption on the premises, only on the following days and hours:

Monday - Sunday from 9:00am - 10:00pm.

- No alcohol is to be sold on, or delivered from, the premises on Good Friday, Easter Sunday or Christmas Day or before 1.00 pm on Anzac Day:
- While alcohol is being supplied free as a sample, water is to be provided to patrons free of charge at the place where the samples are 3. being supplied.
- The whole of the premises is designated as a Supervised Area;
- The Licensee must have available for purchase on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low alcohol beverages.
- A properly appointed Certificated, or Acting or Temporary, Manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the premises.
- The Licensee must display:
 - a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons.
 - b. At the principal entrance to the premises, so as to be easily read by people immediately outside the premises, a sign stating the ordinary hours of business during which the premises will be open for sale of alcohol.
- A sign prominently displayed at the premises, which identifies by name the manager for the time being on duty.
- This licence is issued subject to the undertaking signed and dated 23 April 2024.

THE LICENSED PREMISES

The sale or delivery of alcohol is authorised in or from the premises generally. The premises, situated at 20 BROOK STREET, PARKVALE, TAURANGA 3112, is more precisely identified as outlined in a plan date stamped as received by the Tauranga District Licensing Committee

DISPLAY OF LICENCE AND PRINCIPAL ENTRANCE/S

A copy of this licence must be displayed at the principal entrance to the premises. The entrance from Brook Street is designated as the principal entrance.

DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force until the close of the period for which it is renewed.
